The service area extends three fourths of a mile beyond the fixed-routes. Points of origin and destinations not within the three fourths of a mile corridor are eligible for ADA service with the understanding that MAT<i>Aplus</i> is only required to provide transportation within the service area.</p> <p>MAT<i>Aplus</i> will schedule service for area outside of the service area only if MAT<i>Aplus</i> has the capacity to provide the service. A trip may require more than one hour from origin to destination due to the size of MAT<i>Aplus</i> service area and group trips.</p> <p>Paratransit trips will be the same as the fixed-route bus system.
